

GIFT PHASE UPDATE

Major Gift Phase in Process

The Major Gift Phase of the campaign is the third of our “quiet phases” of the *Building Our Legacy, Every Student... Every Day* Capital Campaign. It has been in process since October. This phase focuses on inviting individuals to make a gift in the range of \$7,500 to \$14,999 over a three-year pledge period.
